

P R E F A C E

Owing to the disturbed condition prevailing in the North Eastern region, the Second Economic Census and the House Listing operations of the 1981 population census could be taken up only in September, 1980. Unlike the first Census (1977 Economic Census) which covered only establishments in the non-agricultural sectors, i.e. enterprises with at least one hired worker on a fairly regular basis, the Second Economic Census had wider scope and coverage as it covered both non-agricultural establishments and own-account enterprises (enterprises with no hired worker). The Second Economic Census also covered agricultural enterprises other than crop production and plantation. Information collected in the census were location of enterprises, nature of operation, type of ownership, social group of owner, power/fuel used for the activity and total number and number of hired persons usually working in the enterprise.

The report gives the findings of the Second Economic Census of the State of Meghalaya based on the final results. It is hoped that the data contained in the report would be found useful for planning and development and also for research workers.

I would like to place on record my appreciation to enumerators drawn locally such as school teachers, village level workers and the third grade Govt. Servants and the supervisors. I also place my thankfulness to the staff of the Directorate of Census Operations Meghalaya and the staff of this Directorate without whose guidance and supervision this difficult task would have been incomplete. Last but not least, I acknowledge with gratitude, the co-operation of the informants of various enterprises in making the difficult task a success.

Chapter - I

Introduction

Fairly sound system of agricultural statistics has been built up through the nation-wide Agricultural Censuses conducted once in ten years. But in the non-agricultural sector of the economy like manufacturing, trade, transport and other services, the availability of statistics is not satisfactory except for the manufacturing establishments registered under Factory Act, 1948. Data regarding manufacturing establishments registered under Factory Act, 1948 are being collected regularly through the Annual Survey of Industries. For the non-factory units i.e. manufacturing establishments using power and employing less than 10 persons or those without power and employing less than 20 persons however, there is no regular collection of dependable statistics.

1.2 The lack of information in the un-organised sectors had led to neglect of developmental planning though these sectors were considered to be very important due to the fact that they accounted one-fourth of the national income and about one-fifth of the country labour force*

1.3 Some attempt were made in the past to collect information on un-organised activities both by the Central Agencies and the States*. Some of the efforts that need mentioning were - (i) Surveys conducted on household non-agricultural enterprises by the National Sample Survey Organisation (N.S.S.O.), (ii) Canvassing of establishments schedules in the 1971 population census, (iii) Census of unregistered industrial units carried out as a plan scheme in 1971-73 and (iv) the survey of Small Scale Industry conducted by the Ministry of Industries and Civil Supply.

1.4 The only attempt made in the State of Meghalaya to fill the data gap prior to the 1977 Economic Census was the survey conducted on household non-agricultural enterprises by the National Sample Survey Organisation in the 29th Round (1974-75). The survey, however, was confined only to self-employment in non-agricultural enterprises,

1.5 A nation-wide attempt to cover the data gap was made in 1977 through the 1977 Economic Census. In the 1977 Economic Census, non-agricultural establishments in the un-organised sector were identified*. The basic data of structure, organisation, employment, output, etc. of those un-organised non-agricultural establishments were collected*. Based on the information collected in the 1977 Economic Census, two follow-up surveys were conducted by the National Sample Surveys Orga-

nisation in the 33rd and 34th Rounds. In the 33rd Round, a detailed enquiry on non-directory manufacturing and repair services was conducted and in the 34th round a detailed study on non-directory manufacturing and repair services was done.

Need to repeat the Economic Census wider in scope and coverage:

1.6 As the 1977 Economic Census covered a large number of small units which were subject to high rate of mobility and mortality and variation in output and turnover, the censuses have to be repeated. The minimum interval best considered is five years. Though the data gap of the non-agricultural establishments in the un-organised sector had been filled to great extent, the 1977 Economic Census did not cover the non-agricultural own account enterprises which were more numerous and also contributed significantly to self-employment and national income. Though the listing of own-account enterprise was in the urban areas and in villages with more than 5000 population was done door to door, in the smaller villages, the Village Level List (V.L.L.) was canvassed and information regarding non-agricultural establishments was collected from headmen and any knowledgeable persons of the village. In the State of Meghalaya, villages with more than 5000 population were non-existent. Hence, a great number of own account enterprises could not be accounted for. Again, the 1977 Economic Census did not cover non-crop agricultural enterprises of which very little information was available. Hence the need for repeated censuses.

CHAPTER - II

Economic Census Programme and tabulation of data.

Period of the census - along with house listing operation of 1981 Population Census.

2.1 The Second Economic Census was normally due in 1982. However, as its operation included listing of addresses of enterprises through house-listing schedules, it was decided to conduct the Economic Census in 1980 along with the House-listing operation of the Population Census, 1981. From the point of view of economy and operational convenience, it was also considered best to hold the census along with House-Listing Operations. In most States of the country the Economic Census was taken up in April, 1980. In Meghalaya, the Economic Census could be taken up only in September 1980 owing to the circumstances prevailing in the North-Eastern Region, disturbed conditions being one. The period of the census was from 1st September, 1980 to 15th October 1980,

House list approach:

2.2 When an enterprise was identified in the houselist schedule, items of information such as description of enterprise, classification of enterprise as to whether agricultural or non-agricultural, nature of operation, type of ownership, social group of owner, power/fuel used for the activity and number of persons usually working daily in the non-agricultural enterprise with males, females, total and also hired males, hired females were recorded in the Enterprise List. Information of number of persons usually working in the agricultural enterprise with total and hired were also collected.

Field agency for enumeration and supervision:

2.3 For the purpose of enumeration, part-time service of teachers of middle and primary schools, village level workers (Gram Sevaks) and third grade Government servants was utilised. In the rural areas school teachers and village level workers worked as enumerators and in the urban area third grade Government servants did the enumeration. In all, 1842 enumerators were engaged. For supervision, part-time services of officials of slightly senior levels were utilised. Each supervisor had to look after the work of approximately five enumerators, 374 supervisors were engaged. For the purpose of the census, the State of Meghalaya was divided into 47 charges, each under a charge-officer who was of a senior rank official. Charge Officers were overall supervisors of their respective charges. The five D.S.O's designated as Additional District Census officer were made overall in-charge for their respective district for the purpose of the Economic Census,

Release of quick result of the Census:

2.4 Arrangements were made for quick tabulation of important items in the Enterprise List by the enumerators themselves as part of the census operation. For this purpose, the Enterprise List Abstract was required to be filled up immediately after the field count by enumerators for the respective blocks; Aggregations at C.D. Block and District levels were done by the district statistical staff for the respective districts to provide district-wise provisional results of items such as total number of agricultural and non-agricultural enterprises, employment, total number of hired employment in those enterprises and selected characteristics of the enterprises. These results were further aggregated at the State headquarter in the Directorate of Economics, Statistics and Evaluation to arrive at the State results,

Preparation of summary statements:

2.5 Summary statements were prepared in the District Statistical Offices. For this purpose, one computer was temporarily appointed in each district. The statements were prepared by these computers under the direct supervision of the District Statistical Officer. Also, C.D. Blocks and town level statements were prepared for the respective district. These statements were sent to the Directorate of Economics, Statistics and Evaluation which were in turn sent to the Central Statistical Organisation, New Delhi.

Arrangements for computer processing of data:

2.6 Since Meghalaya did not have the computer facilities, processing of the Enterprise List data was done in the Computer Centre Department of Statistics, Government of India, New Delhi.

From table 3.1 of the Report it is seen that out of 32370 enterprises identified in the State, agricultural enterprises other than crop production and plantation constituted 7.76 percent only while non-agricultural enterprises constituted 92.24 percent. The percentage share of persons usually working in the Agricultural enterprises and non-agricultural enterprises was 6.15 and 93.85 respectively. In the case of agricultural activities, the number of own-account enterprises was more than that of the establishments but in the case of non-agricultural activities, the number of establishments was more than that of own-account enterprises. The percentage share of hired workers to persons usually working in the agricultural sector was 27.51 while that of the non-agricultural sector 73.25. In both agricultural and non-agricultural activities, the number of rural enterprises was more than that of urban enterprises.

3.2 Inter-district comparison on concentration of enterprises in respect of population.

In the rural areas, the number of enterprises per 1000 population was highest in the Jaintia Hills and East Garo Hills because the rural population of the two districts was relatively less than in the remaining districts. The West Khasi Hills district had the lowest number of rural enterprises per 1000 population as it had the lowest number of rural enterprises. In the case of urban areas West Khasi Hills had the highest number of enterprises per 1000 population because its urban population was only 3880 though the number of urban enterprises was only 282. This has a reference to table 3.7 of the report.

3.3 Inter-district comparison of concentration of enterprises with respect to area-

Table 3.8 reveals that the East Khasi Hills district had the highest number of rural enterprises per 10 Sq.Km. followed by East Garo Hills and West Garo Hills. In the urban area East Khasi Hills also ranks first* Though the number of urban enterprises of Jaintia Hills was much less than that of West Garo Hills yet it ranks second as its urban area is less than one-third that of West Garo Hills.

3.4 Comparison between State final result and All-India Provisional results of 1980 Economic Census*

Meghalaya being a very small and young State of India, the number of enterprises is also very small compared to that of the All India- Table 3.9 shows that the percentage share of Meghalaya to All India in respect of agricultural enterprises other than crop production and plantation was 0.17. In the case of non-agricultural enterprises the percentage share of Meghalaya to All India was 0.18. The combine percentage share was 0.18. The percentage share of persons usually working in the agricultural enterprises was 0.23 and that of hired workers 0.25. The percentage share of persons usually working in non-agricultural enterprises was 0.21 and that of hired workers was 0.27. Its share of persons usually working in agricultural and non-agricultural combined in the All India figure was 0.21 and that of hired workers 0.27.

The increase in the number of establishments between the period of the two censuses as seen in Tables 2.4 and 3.10 was to the tune of 235 percent. This tremendous increase in the number of establishments may be ascribed to the following: (a) In the 1977 Economic Census, complete enumeration was not done in the village with less than 5000 population. The village level List Approach was instead adopted. In this approach the enumerator sought information about the establishments in the village from knowledgeable person/persons such as headman, local committee Secretary, etc. This method adopted in the 1977 Economic Census had apparently resulted in under-enumeration of establishments in the rural areas as multi-establishments house holds were counted mostly only once. In Meghalaya, villages with more than 5000 population were negligible in number. But in the 1980 Economic Census, complete enumeration was done in all villages irrespective of their population. This was one of the reasons of the increase in the number of establishments in the rural areas because the chances of under-enumeration was much less in the complete enumeration approach.

(b) Two new districts were set up in the State just before the 1977 Economic Census and many sub-divisions and administrative units were set after the 1977 Economic Census*. As a result, many establishments were set up in these district head-quarters, sub-divisions and administrative head-quarters only after the 1977 Economic Census. This was another reason for the increase of establishments in the 1980 Economic Census over that of the 1977 Census.

(c) A huge deposit of coal was discovered in the Jaintia hills District of the State of Meghalaya scattering over a number of areas. These quarries started working just after the 1977 Economic Census - thus leading to increase of mining and quarrying establishments after the 1977 Economic Census. Side by side, many other activities like retail trade, hotels and restaurants, transports, repair services, construction sprung up in these areas,

These three reasons together mainly accounted for the tremendous increase of establishments in the 1980 Economic Census over the 1977 Economic Census.

CHAPTER - IV

Principal Characteristics of agricultural enterprises

4.1 The total number of agricultural enterprises as identified by the Census was 2533, of this number, 1581 were own-account enterprises and 932 establishments. Persons usually working in agricultural enterprises were 6672 of whom 1836 were hired workers.

District-wise distribution of agricultural own-account enterprises and persons usually working.

4.2 From the table below it is seen that the highest concentration of own-account agricultural enterprises and persons usually working therein was in the East Khasi Hills district.

4.3 The total number of persons usually working in agricultural establishments as given in table 4.5.3 was 3131 of which 1836 were hired workers. The percentage share of hired workers to total persons usually working as given in table 4.6 was 58.64. The percentage share of urban workers to total workers was only 28.74 (Table 4.4). Of the 1581 agricultural own-account enterprises as seen in table 4.7.3 254 were operated seasonally and 304 without premises. 598 enterprises were owned by Scheduled Tribe and 53 by Scheduled Castes. Those with power/fuel were 54 in number.

4.4 Table 4.8.3 shows that out of the 332 agricultural establishments identified in the state, 97 were operated seasonally and 155 were without premises. 3 agricultural establishments were co-operative establishment and 122 public establishments. Those owned by Scheduled Tribe and Scheduled Castes were 218 and 23 in number respectively. Agricultural establishments with power/fuel were 21 in number.

4.5 The total number agricultural private establishments was 807 and the total number of persons usually working in these establishments was 2731. Of the total private establishments, 75 were operated seasonally and 153 without premises, 218 of the establishments were owned by Scheduled Tribe and 29 by Scheduled Caste. 16 establishments were operated with power/fuel.

4.6 Only 3 agricultural co-operative establishments were identified, All of them were perennial and with premises. These co-operative establishments employed 10 workers only, All of them were without power/fuel.

CHAPTER - V

Principal Characteristics of non-agricultural enterprises.

5.1 The total number of non-agricultural enterprises as identified in the Census was 29857 with 191906 persons usually working in them. Of the total non-agricultural enterprises, 12949 were own-account enterprises and 16908 were establishments.

Total persons employed in own-account enterprises and establishments by Major activity groups.

5.2 Table 2.6 shows that the highest concentration of persons usually working in non-agricultural own-account enterprises was in wholesale and retail trade with 53.16 percent of the total employment in non-agricultural own-account enterprises followed by manufacturing and repair services with 23.44 percent. The highest concentration of persons usually working in respect of non-agricultural establishments was in Community, Social and Personal Services with 57.61 percent of the total number persons usually working in non-agricultural establishments.

5.14 As mentioned in para 5.8, the most important industry in So far as women employment is concerned was in community, social and personal services with 10368 in number which accounted for 44.98 percent of the total women usually working in all non-agricultural activities. This was followed by wholesale trade with 18.78 percent of the total women employment. CHAPTER - VI

Principal characteristics of agricultural enterprises by size class of total employment.

Number of agricultural own-account enterprises by size class of total employment.

6.1 The highest number of agricultural own-account enterprises as revealed in tale 6.1 were in the employment size class of 1-2. They constituted 73.05 percent of the total agricultural own-account enterprises of the State. Next comes agricultural own-account enterprises with employment size class 3 constituting 13.41 percent. Agricultural Own-account enterprises with employment size class of 10 or more are 13 in number constituting only 0.82 percent of the total. In the rural areas own-account enterprises of employment size class 1-2 are maximum in number. They constituted 71.00 percent of the rural total. Next comes employment size class of 3 with 14.17 percent. In the case of urban concentration, own-account enterprises of employment size class 1-2 are highest in number with 79.84 percent of the urban total.

The distribution of other size classes are as follows: size class 4 with 12.90 percent, 5 with 6.33 percent, 6 to 9 with 6.87 percent, 10 to 19 with 2.57 percent and 20 to 49 with 0.54 percent. No establishment in the range of 59-99, 100-199, 200-299 and 500 or more was identified in the State during the census. In the rural areas, establishments of employment size class 1-2 are highest in number with 44.03 percent of the rural total followed by size 3 with 27.76 percent. In the case of urban areas, establishments in employment size class 1-2 were highest in number with 38.55 percent of urban total. Size class 3 ranked second with 29.39 percent. Urban distribution of other employment size classes were as follows:- size class 4 with 14.12 percent, size class 5 with 8.78 percent, size class 6-9 with 7.25 percent, size class 10 to 19 with 1.15 percent and size class 20 to 49 with 0.76 percent. No agricultural establishment of size class 50 and above was identified in the State. Table 6.2 gives the distribution of agricultural establishments by employment size class.

6.4 Except for the size class 20-49 overtaken by the East Garo Hills district, the East Khasi Hills district ranked first in all size classes with 38.33 percent, 59.70 percent, 50.20 percent 54.24 percent, 48.44 percent and 50 percent of size class 1-2, 3, 4, 5, 6-9 and 10-19 respectively as seen in table 6.4.3. Agricultural establishment above size class 50 was not identified in the state. In the rural areas, the highest number of agricultural establishments of size classes 1-2, 3, 4 and 10-19 was in the East Khasi Hills district while the East Garo Hills district claimed first in Size classes 5, 6-9 and 20-49 as seen in table 6.4.1. As regard urban concentration of agricultural establishments, the East Khasi Hills district ranked first in all size classes except size class 20-49 which was equally shared by the West Garo Hills and East Khasi Hills district. 7.3 Table 2-31 shows that manufacturing and repair services ranked first in size classes 4, 5, 6-9 and 10 or more. The percentage share of manufacturing and repair services in size class 4 was 38.86. Next comes whole-sale and retail trade with 31.75 percent followed by restaurants with 19.91 percent. There was no construction own-account enterprises of size class 4. In size class 5, whole-sale and retail came second with 31.30 percent and restaurants and hotels third with 20.61 percent while in size class 6-9 restaurants came second with 25.32 percent. ANNEXURE - I

Concepts and definitions of certain terms used during the census.

Enterprise:

An enterprise is an undertaking engaged in production and/or distribution of good and/or services not for the sole purpose of own consumption. The workers in an enterprise may consist of members of the household or hired workers or both.

Agricultural Enterprise:

The agricultural enterprise is one engaged in livestock production, agricultural services, hunting trapping and game propagation, forestry and logging. Enterprises engaged in activities pertaining to agricultural production and plantation were not covered under the Economic Census,

Non-Agricultural Enterprises:

Enterprises engaged in activities other than those mentioned above are term as non-agricultural enterprises.

Own-account Enterprises:

An own-account enterprise is an enterprise with no hired worker.

Establishment:

An establishment is an enterprise having at least one hired worker on a fairly regular basis. It is further classified into Directory Establishment and Non-Directory Establishment,

Directory Establishment:

A directory establishment is an establishment employing six or more workers with at least one hired worker.

Non-Directory Establishment:

A non-directory establishment is an establishment employing less than six workers with at least one hired worker.




